Description of the area covered by the agreement

The agreement area is described in clause 3.11 and means "all the land and waters subject to that part of Pastoral Lease Number 2495 recorded in Crown Lease Register Book Volume 1628 Folio 19 known as Tieyon (excluding any existing public roads) which falls within native title determination application SAD208/2010 Tjayiwara Unmuru (SC2010/005) as per the Form 1 filed in the Federal Court on 17 December 2010, being an area west of a line defined as: Commencing at a point on the southern bounday of Pastoral Lease CL 1628/19 (Tieyon) at Longitude 133.850000 degrees East, (being also a point on the northern boundary of Native Title Determination SAD6022/1998 Yankunytjatjara Antakirinja (SC1997/009) as determined in the Federal Court on 28 August 2006), and extending northerly to a point on the northern bounday of Tieyon pastoral lease at Longitude 133.900000 degrees East (see Third Schedule)".

The following general description of the agreement area has been provided by the National Native Title Tribunal to assist people to understand the location of the agreement area. It is provided for information only and should not be considered part of the Register of ILUAs:
