**ILUA Area** means portion of Allotment 69 in Deposited Plan 85851 and portion of Piece 71 in Deposited Plan 85851 in the Hundred of Cultana shown as Piece 3\* and Piece 4\* in the plan attached at *Schedule 1* and **Land** has a corresponding meaning;

## Statements of the kind mentioned in ss. 24EB(1) or 24EBA(1) or (4)

12.1 BDAC and the Barngarla People surrender to the State all of their Native Title in the ILUA Area. 12.2 The surrender of Native Title pursuant to this clause will take place upon the issue of a Certificate of Title in favour of BDAC and wholly extinguishes the surrendered Native Title.

12.3 For the purpose of section 24EB of the NTA, the Parties consent to the surrender of Native Title pursuant to this clause.

12.4 The Parties agree that Subdivision P of Part 2 Division 3 of the NTA (which deals with the Right to Negotiate) is not intended to apply to the surrender of Native Title pursuant to this clause.
