### Description of the area covered by the agreement

The agreement area is described in Schedule 2 to the agreement as the entirety of Crown Allotment 2037 in the Parish of Hazelwood, as defined in Title Plan 946004D.

The following general description of the agreement area has been provided by the National Native Title Tribunal to assist people to understand the location of the agreement area. It is provided for information only and should not be considered part of the Register of ILUAs:

The agreement area covers Crown Allotment 2037 on Title Plan 946004D which is an area of about 0.286 sq km located approx. 3.7km south east of Morwell.]

**Statements of the kind mentioned in ss. 24EB(1) or 24EBA(1) or (4)**

7(a) GLAWAC, on behalf of the Gunai Kurnai Native Title Holders, surrenders, and consents to the surrender to the State of all native title rights and interests over the entire ILUA Area .

(b) The parties intend that the surrender of native title under clause 7(a) is intended to extinguish the native title rights and interests.

(c) Any surrender of native title under clause 7(a) takes effect immediately before the making of a sale of Crown Allotment 2037 in the Parish of Hazelwood.

9. The parties intend that Subdivision P of Division 3 of Part 2 of the NTA (which deals with the right to negotiate) does not apply to the sale of Crown Allotment 2037 in the Parish of Hazelwood to the surrender of native title rights and interests under clause 7.
