4.(a) This Agreement commences on the Commencement Date and, subject to clause 4(b), will operate for the duration of the Agreed Acts and the undertaking of the ILUA Project (Term). (b) Clauses 3 (Authority to enter into agreement), 8 (Consents) (in relation to things done prior to the date of termination), 11 (Satisfaction of compensation) and 15 (Confidentiality) survive termination of this Agreement.

1.1 Commencement Date means the earlier of:

(a) the date on which this Agreement and the Ancillary Agreement are executed by the last of the Parties; and

(b) the "notification day" for this Agreement within the meaning of section 24CH(3) of the NTA.

Statements of the kind mentioned in ss. 24EB(1) or 24EBA(1) or (4)

8(a) The Parties agree to and consent to:

(i) the Agreed Acts, without conditions; and

(ii) the undertaking of the ILUA Project [Fairview Pipeline Project and Eurombah Creek Lateral Project].

(d) For the purposes of section 24EB(1)(c) of the NTA [Native Title Act 1993(Cth)] and regulation 7(5)(b) of the Regulations [Native Title (Indigenous Land Use Agreements) Regulations 1999 (Cth)], APLNG and the Iman People state that Subdivision P, Division 3, Part 2 of the NTA is not intended to apply to any Agreed Acts on and from the date this Agreement is Registered.
