3.1 This agreement takes effect from the day it is executed by all parties (in accordance with clause 14)

### Statements of the kind mentioned in ss. 24EB(1) or 24EBA(1) or (4)

- 5.1 The parties agree that the right to negotiate provisions in Part 2, Division 3, Subdivision P of the NTA are not intended to apply to the grant of fee simple title to the proponent over the ILUA
- 5.2 Subject to compliance by the parties with the provisions of this Agreement, the parties:
- · agree to the grant by the State of fee simple title under s.99 A of the Land Act 1958 to the Proponent in respect of the ILUA Area; and
- agree that the grant of fee simple title to the Proponent in respect of the ILUA Area is valid .
- 6.1 The registered native title claimants for and on behalf of the Dja Dja Wurrung native title claim group, upon registration of this Agreement, surrender to the State native title rights and interests (if any) in and relating to the ILUA land.
- 6.2 The Parties consent that, pursuant to s 24EB(1)(d) of the NTA, the surrender of native title rights and interests (if any) pursuant to clause 5.1 [6.1] is intended to extinguish those native title rights and interests.
