#### Description of the area covered by the agreement

Schedule 1 of the agreement describes the ILUA Area as all the land and waters within the boundary of the Town of Kalkarindji as proclaimed in the Australian Government Gazette on 5 October 1976, and as depicted on Survery Plan S83/205 and on Map 2.

[Maps 1, 2,3 and 4 of the agreement area are contained in Schedule 1 of the agreement. A copy of Schedule 1 is attached to this register extract.

The following general description of the agreement area has been provided by the National Native Title Tribunal to assist people to understand the location of the agreement area. It is provided for information only and should not be considered part of the Register of ILUAs:

The agreement area covers about 6.15 sq km over the township of Kalkarindji situated approximately 370 km south west of Katherine].
