## Description of the area covered by the agreement

Clause 1.(1) of the agreement defines the **"Agreement Area"** as the whole of the land and waters within the external boundaries of: (a) the KM Claim as it existed immediately prior to 1 November 2016; and

(b) the YM Claim.

The Agreement Area is depicted on the map in Schedule 2.

The following general description of the agreement area has been provided by the National Native Title Tribunal to assist people to understand the location of the agreement area. It is provided for information only and should not be considered part of the Register of ILUAs:

The agreement area covers about 21422 sq km and is located in the vicinity of the Pannawonica township, 122 km north west of Paraburdoo and 66 km north east of Onslow.]

5.1 This deed commences on the Execution Date.

5.2 This deed will terminate upon the happening of one of the following events, whichever is the earlier:

(1) the agreement in writing signed by KMAC and the YM PBC; or

(2) a Party terminates this deed in accordance with clause 14 [Default Termination].

"Execution Date" means the first date on which this deed is executed by all Parties, and in the absence of evidence to the contrary shall be taken to be the date (if any) inserted at the top of page 1 of this deed.

**"KMAC"** means the first mentioned Party to this deed, or a successor body corporate in accordance with clause 3.1 (3).

"Parties" means the parties to this deed and "Party" means any one of them.

"YM PBC" means the second mentioned Party to this deed, or a successor body corporate in accordance with clause 3.2(3).
