External Boundary:

Commencing at a point in Broad Sound at Longitude 149.784740° East, Latitude 22.395110° South and extending northerly along a line drawn to Longitude 149.873617° East, Latitude 22.039361° South to its intersection with the Low Water Mark; then generally south-easterly, generally north-easterly, again generally south-easterly and generally southerly along that low water mark to approximately Latitude 22.774540° South, being the intersection with the easterly prolongation of the southern boundary of Lot 1 on RP898342; then westerly along that prolongation and the boundary of that parcel to the northern eastern corner of Lot 865 on FTY1975 (Byfield State Forest); then generally westerly, generally southerly and general south westerly along the northern and western boundaries of that lot, eastern boundaries of Lot 1 on RP898342 and again western and northern boundaries of Lot 865 on FTY1975 (Byfield State Forest) to the southern bank of the Shannon River; then generally south westerly along the southern bank of that river to approximately Latitude 22.929875° South, also being the intersection with the eastern prolongation of southern boundary of Lot 830 on FTY 591 (Werribee Creek State Forest); then south westerly to the south eastern corner of Lot 810 on FTY961 (Canal Creek State Forest); then generally westerly and southerly along the boundary of that lot to its southernmost eastern corner; then again south westerly to the south eastern corner of Lot 2314 on LIV40867 at approximate Latitude 22.966729° South; then generally south westerly and generally westerly along the eastern and southern boundaries of that lot, the southern boundaries of the northern severances of Lot 10 on LN913 and Lot 11 on RP889901, southern boundaries of Lot 33 on LI190, Lot 928 on LBG4039, the northern severances of Lot 1044 on

LBG4052 and Lot 42 on LI244 to the intersection with the north eastern boundary of Kunwarara Road; then generally north westerly and generally westerly along the north eastern and northern boundary of that Road to the intersection with the northern boundary of the North Coast Railway (being Lot 291 on SP108279); then generally westerly and generally north westerly along the northern boundary of that Railway (being Lot 291 on SP108279, Lot 2 on LI87, Lot 2 on LI88, Lot 2 on LI89, Lot 300 on SP108280, Lot 321 on SP108281, Lot 322 on SP108281, Lot 2 on LI96, Lot 2 on RP600784, Lot 4 on LI96, Lot 341 on SP108282, Lot 2 on LI94, Lot 361 on SP108283, Lot 371 on SP108284, Lot 21 on SP108645, again Lot 371 on SP108284, Lot 24 on SP108645, Lot 23 on SP108645, Lot 22 on SP108645, again Lot 371 on SP108284, Lot 2 on RP602110, Lot 381 on SP108285, Lot 5 on RP602110, Lot 5 on RP602111, Lot 2 on SP602111, Lot 391 on SP108286, Lot 393 on SP108286, Lot 2 on RP602114, Lot 2 on LI129, Lot 1 on LI129, Lot 411 on SP108287, Lot 412 on SP108287, Lot 450 on SP108288 and Lot 461 on SP108289) to Latitude 22.649507° South; then westerly and north westerly passing through Longitude 149.674918° East, Latitude 22.649507° South to a point on the eastern bank of Deep Creek at Latitude 22.648494° South, then generally westerly along banks of that creek to Longitude 149.670930° East: then southerly to the centreline of that creek at Longitude 149.670864° East: then generally north-westerly, generally northerly and generally north-easterly along the centre line of that creek, the centre line of Tooloombah Creek and the centreline of Styx River to Broad Sound; then north-easterly back to the commencement point.

The ILUA Area also includes the land and waters subject to Girt Island landward of the High Water Mark.

To avoid any doubt, the ILUA Area does not include any land or waters seaward of the Low Water Mark.
