### Item 1 Description of Agreement Area

## A. External boundary description

The agreement area includes all of the land and waters within Lot 4844 on PH1679 (Mount Fullstop Pastoral Holding) located within the Native Title Determination Application QUD85/05 Gugu Badhun People 2 (QC05/07) being an area north of the line described below:

Commencing at the intersection of the northeast boundary of Lot 4844 on PH1679 (Mount Fullstop Pastoral Holding) and the northern bank of the Burdekin River and extending generally south westerly along that bank to Longitude 145.482387° East (at the junction with the Clarke River); then westerly to the northern bank of the Clarke River; then generally south westerly along that bank to the northern boundary of the Gregory Development Road; then generally north westerly along that boundary to the intersection of the western boundary of Lot 4844 on PH1679.


