DESCRIPTION OF THE AGREEMENT AREA

Wanna Station and Combined Thiin-Mah Warriyangka, Tharrkari, Jiwarli ILUA

External boundary description

The agreement area covers all the land and waters within the external boundary described as:

That part of Wanna Pastoral Lease (N049430) that falls within Native Title Determination Application WAD464/2016 Combined Thiin-Mah Warriyangka, Tharrkari Jiwarli (WC2016/003) further described as:

- A. That part of Lot 19 on P238190 (Part Wanna Pastoral Lease (N049430) north westerly of the western boundary of Native Title Determination WAD6033/1998 Wajarri Yamatji (WCD2017/007), being a line commencing at the intersection of the western boundary of Mt Augustus Pastoral lease (N050129) and the centreline of Koorabooka Creek and extending generally southwesterly and westerly along the centreline of that Creek to Longitude 116.512528° East; then generally southwesterly passing through the following coordinate points:

That part of Lot 23 on P238190 (Part Wanna Pastoral Lease (N049430) north westerly of the western boundary of Native Title Determination WAD6033/1998 Wajarri Yamatji (WCD2017/007) and the northern boundary of Native Title Determination Application WAD22/2019 Gnulli (WC1997/028), being a line extending generally south westerly and westerly passing through the following coordinate points:
