SCHEDULE 1. AGREEMENT AREA

The Agreement Area incorporates all land and waters within the external boundary described herein, excluding the township of Iron Knob (further described below). The external boundary described follows pastoral lease¹ boundaries or road reserve boundaries.

External Boundary Description

Commencing at the north eastern corner of Section 13 in the Hundred of Jenkins of Lincoln Park Pastoral Lease, Point 1, and extending generally southerly, and generally westerly along the boundaries of Lincoln Park Pastoral Lease to the eastern boundary of Tregalana Pastoral Lease; then generally southerly, north easterly, southerly and generally westerly along the boundaries of Tregalana Pastoral Lease to a south eastern corner of Roopena Pastoral Lease; then generally southerly, generally westerly and generally northerly, along the boundaries of Roopena Pastoral Lease to the south eastern corner of Katunga Pastoral Lease; then generally westerly, northerly, again generally westerly, then south westerly adjacent to the Eyre Highway road reserve and again northerly along boundaries of the Katunga Pastoral Lease to the southern boundary of Corunna Pastoral Lease; then generally westerly, generally northerly, generally easterly and generally southerly along the boundaries of Corunna Pastoral Lease to the southern boundary of the Eyre Highway road reserve, being the northern boundary of Piece 3, Deposited Plan 72921 of Pandurra Pastoral Lease; then generally easterly and along the boundaries of that road reserve to the eastern boundary of Pandurra Pastoral Lease; then generally southerly, easterly, then southerly again along the boundary of Pandurra Pastoral Lease to the north western corner of Tregalana Pastoral Lease: then generally easterly along boundaries of Tregalana Pastoral Lease to the north western corner of Section 13 in the Hundred of Jenkins of Lincoln Park Pastoral Lease; then generally easterly along the northern boundary of that section back to Point 1.

Excluded Area - Iron Knob Township

The Agreement Area excludes the township of Iron Knob comprising the following:

The external boundary of the excluded area is described as follows:

Commencing at Point 2, being the south eastern corner of Allotment 11 of Deposited Plan 26331 and also being a point on the northern boundary of Katunga Pastoral Lease and extending generally westerly and generally northerly along the boundaries of Katunga Pastoral Lease to a south eastern corner of the southern boundary of Corunna Pastoral Lease; then again generally northerly, generally easterly and generally southerly along boundaries of Corunna Pastoral Lease back to Point 2.

The Agreement Area excludes any area subject to amended application SAD6020/98 Gawler Ranges Native Title Claim (SC97/7) as filed in the Federal Court on 02/03/1999
