

## SCHEDULE B

### DESCRIPTION OF THE AGREEMENT AREA

#### Glen Florrie Station and Combined Thiin-Mah Warriyangka, Tharrkari, Jiwarli ILUA

##### External boundary description

The agreement area covers all the land and waters within the external boundary described as:

That part of Glen Florrie Pastoral Lease (N050594) that falls within Native Title Determination Application WAD464/2016 Combined Thiin-Mah Warriyangka, Tharrkari, Jiwarli (WC2016/003) further described as:

That part of Glen Florrie Pastoral Lease (N050594) that falls easterly, southerly and westerly of a line commencing at Longitude 116.381016° East, Latitude 23.382180° South, being a point on the eastern boundary of Native Title Determination WAD6212/1998 Thudgari People (WCD2009/002), and extending north westerly along the boundary of that determination toward a point at Longitude 116.060854° East, Latitude 22.938565° South to its intersection with the centreline of an unnamed creek at Latitude 22.943786° South; then generally south easterly and generally north easterly along the centreline of that unnamed creek to its intersection with the western boundary of the northern severance of Native Title Determination WAD62/2016 Jurruru People #3 (WCD2018/018) at Latitude 22.963596° South. Then generally southerly along the western boundary of that determination passing through the following coordinate points:

For the avoidance of any doubt, the agreement excludes any area subject to:

- Native Title Determination WAD62/2016 Jurruru People #3 (WCD2018/018) as determined by the Federal Court on 20 December 2018.

- Native Title Determination WAD6212/1998 Thudgari People (WCD2009/002) as determined by the Federal Court on 18 November 2009.
