"ILUA Area" is defined as the land and waters described in Schedule 1 and shown on the map in Schedule 2.

Schedule 1 of the agreement describes the agreement area as all of the land and waters described as Lot 3 on Plan AY23 (Wilandspey Conservation Park) and Lot 7 on Plan NPW199 (Blackwood National Park).
