- 3.1 Subject to clause 3.2, this ILUA commences on the Commencement Date.
- 3.2 Clause 7 commences on Registration of the ILUA with the Tribunal.
- 3.3 In the event the Native Title Party:-
- (a) do not obtain a Determination of Native Title from the Federal Court that native title exists over the ILUA Area; or (b) another Aboriginal group obtains a Determination of Native Title from the Federal Court that they hold native title over the ILUA Area,

the Corporation may at its absolute discretion terminate this ILUA.

- 4.4 Subdivision P of Division 3 of Part 2 of the NTA [Native Title Act 1993 (Cth)] is not intended to apply to any Future Acts for which the Native Title Party has given consent under this ILUA.

- "Agreed Acts" means:- (a) the grant of an Aboriginal Trustee Lease by the [Woorabinda Aboriginal Shire] Council over the ILUA Area for a period of 99 years for School Purposes to the Corporation; (b) the construction of the School and associated buildings and improvements including access road, Principal's residence, caretaker residence, stables, vocational training facilities, paddocks and horticultural areas generally in accordance with the concept plans.
