## Description of the area covered by the agreement

"ILUA Area" means the seas known as Investigator Road [depicted in the map at Attachment 2 and described in Schedule 1].

[A copy of Attachment 2 and Schedule 1 is attached to this register extract.

The following general description of the agreement area has been provided by the National Native Title Tribunal to assist people to understand the location of the agreement area. It is provided for information only and should not be considered part of the Register of ILUAs:

Agreement covers about 6000 sq m in the seas known as Investigator Road within the South Wellesley Islands, Gulf of Carpentaria, centred at 17° 7'15"S, 139°34'54.3"E].

## 2. Term of this Agreement

- (a) Subject to clause 8.8, this Agreement commences on the Commencement Date and terminates on the date that is two years from the Commencement Date.
- (b) The Parties agree that no breach of this Agreement by any Party will give to any other Party as right to elect to terminate this Agreement, but that Party may exercise any other remedy available to it in respect of such breach.

## 8.8 Continuation of some provisions

Clauses 1, 5.3, 6.2, 7(b), 7(c) and 8 survive the expiry or termination of this Agreement.

"Commencement Date" means the day on which this Agreement is executed by the Parties and if executed on different days, the later of those days.

# Statements of the kind mentioned in ss. 24EB(1) or 24EBA(1) or (4)

- 4.1 Consent to removal of the Mooring Buoy
- (a) The Parties consent to:
- (i) the removal of the Mooring Buoy;
- (ii) the Grant of any Interest reasonably required for the removal of the Mooring Buoy; and
- (iii) the doing of any Future Act reasonably required for the purpose of the acts contemplated in clauses 4.1(a)(i) and 4.1(a)(ii).
- (b) The consent provided by GRAC [Gulf Region Aboriginal Corporation RNTBC] under clause 4.1(a):
- (i) constitutes consent for the purposes of any applicable Law; and
- (ii) is subject to substantial compliance by MMG with its obligations under this Agreement.
- 4.2 Removal of the Mooring Buoy
- (a) MMG agrees to remove the Mooring Buoy in accordance with the Removal Process.
- (b) MMG agrees to:
- (i) give GRAC at least 30 days' written notice of the day or days during which MMG proposes to remove the Mooring Buoy; and
- (ii) make all reasonable arrangements to facilitate Monitors being present during the removal of the Mooring Buoy.
- "Interest" means approval, permit, licence, authorisation, direction, consent, permission, exercise of a discretion, or other authority by or from an Government Agency or other competent authority reasonably required for the removal of the Mooring Buoy.
- "Monitors" means up to four Kaiadilt People who have traditional responsibility for the ILUA Area.
- "Mooring Buoy" means the mooring buoy for the Mooring Anchorage.
- "Mooring Anchorage" means the offshore cyclone anchorage for the MV Wunma located approximately one nautical mile off Sweers Island between Sweers Island, Fowler Island and Bentinck Island, at approximate location 17° 7'15"S, 139°34'54.3"E.
