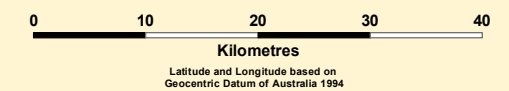

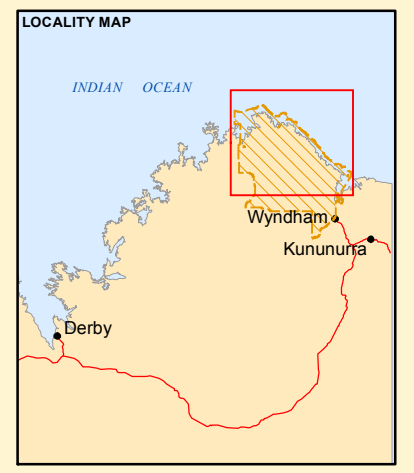


DATA SOURCES
