SCHEDULE 1 - EXTERNAL BOUNDARY OF THE AGREEMENT AREA

The Agreement Area comprises all land and waters covered by the determination made on 13 December 2011 as part of Federal Court Judgement King on behalf of the Eringa Native Title Claim Group and the Eringa No 2 Native Title Claim Group v the State of South Australia [2011] FCA 1387 and the determination made on 11 September 2008 as part of Federal Court Judgement Eringa, Eringa No 2, Wangkangurru/Yarluyandi and Irwanyere Mt Dare Native Title Claim Groups v State of South Australia [2008] FCA 1370, as depicted in the map contained in Schedule 2.

The Agreement Area comprises the Witjira National Park including Mount Dare Lease Area, being the whole of Section 1495 Out of Hundreds Dalhousie and the area immediately to the south as described as follows:

Commencing at a point being the intersection of the northern boundary of Block 1198, OH(Dalhousie) with the centreline of Stevenson River. Thence generally south-easterly along the centreline of Stevenson River to its intersection with the centreline of Macumba River. Thence generally south-easterly along the centreline of Macumba River to its intersection with Longitude 135.716786 degrees East, Latitude 27.204628 degrees South and generally easterly along the centreline of Macumba River to its intersection with the production southerly of the western boundary of Block 565, OH(Dalhousie).

Thence northerly along the said production and the said western boundary of Block 565, OH(Dalhousie) and the western boundaries of Block 564, OH(Dalhousie) and Block 563, OH(Dalhousie) to its intersection with the South Australian/Northern Territory border. Thence westerly along the South Australian/Northern Territory border to the north-eastern corner of Block 1264, OH(Dalhousie).

Thence generally southerly and westerly along the eastern and southern boundaries of the said Block 1264, OH(Dalhousie) to the north-eastern boundary of Block 1253, OH(Abminga).

Thence generally south-easterly along the eastern boundaries of the said Block 1253, OH(Abminga) to its intersection with the northern boundary of Block 1198, OH(Dalhousie). Thence westerly along the northern boundary of Block 1198, OH(Dalhousie) to the point of commencement.

Reference datum:
