### Description of the area covered by the agreement

The Agreement Area means the geographical area to which this Agreement applies, being that portion of Pastoral Lease Number 2406 recorded in Crown Lease Register Book Volume 1350 Folio 18 known as Pandie Pandie (excluding all existing public roads) and that portion of Pastoral Lease Number 2387A recorded in Crown Lease Register Book Volume 1597 Folio 91 known as Beckwith (excluding all existing public roads) that is within the external boundary of native title determination application SAD6016/98 - The Wangkangurru/Yarluyandi Native Title Claim (SC97/3) as amended in the Federal Court on 13 November 2009, being an area northwest of a line defined as:

Commencing at a point on the South Australia - Queensland border at Longitude 140.001231 degrees East, also being the north western corner of native title determination application SAD6024/98 Yandruwandha/Yawarrawarka Native Title Claim (SC98/1), then generally south-westerly along boundaries of that application passing through the following coordinate points:
