Description of the area covered by the agreement

'ILUA Area' is defined in Schedule 1 as meaning 'the area described in writing in Schedule 2 including all the land and waters within the (sic) that part of the Claim Area described as 'Darambal Part A' in the Orders made by Justice Collier on 27 March 2013 and shown on the map marked 'ILUA Area' in Schedule 3 which does not overlap with any other native title claim'.

Schedule 2 states that 'the ILUA Area is wholly within the Darumbal People native title determination application (QUD6131/1998) as per the Second Further Amended Claimant Application filed on 24 November 2015. The ILUA Area covers all the land and waters within Livingstone Shire Council local government area and the Rockhampton Regional local government area to the extent that those areas fall within the external boundary described below [a description is set out in Schedule 2, which is attached to this Register Extract]'.

[The following general description of the agreement area has been provided by the National Native Title Tribunal to assist people to understand the location of the agreement area. It is provided for information only and should not be considered part of the Register of ILUAs:

The agreement covers about 14842.3 sq km located west of Yeppoon approx. 47.5 km north west of Gladstone.]
