Technical Description - ILUA Area

Description of External Boundary

Commencing at the easternmost southeastern corner of Roebuck Plains Pastoral Lease (Roebuck Plains P/L) being also a corner of Native Title Determination Rubibi Community: WAD6006/1998, WAD223/2004 (Rubibi Community) and extending northerly along the boundary of that pastoral lease and that determination to their intersection with the northern boundary of Petroleum Production Licence Application STP-PRA-0004 (PPLA); then westerly and southerly along the boundaries of that PPLA to its intersection with a line parallel to, and offset 50m north from, the boundaries of Roebuck Plains and Rubibi Community; then generally westerly along that offset to a point at approximately Latitude 17.989864°South and Longitude 122.996492°East; then northerly to a northern boundary of Roebuck Plains P/L (and Rubibi Community) at Longitude 122.996563°East; then westerly and northerly along the boundaries of that pastoral lease and determination to their intersection with the southern boundary of Reserve 9697; then extending northerly along the boundary of that determination to the northern boundary of Reserve 9697; thence generally south westerly along the boundary of that reserve to Longitude 122.982814°East; thence southeasterly to a point at approximately Latitude 17.737801°South and Longitude 122.986331°East; thence northeasterly to a line parallel to, and offset 50m west of, the boundaries of Roebuck Plains and Rubibi Community at Latitude 17.733310°South; then generally southerly along that 50m offset to Latitude 17.815081°South; then southeasterly to a line parallel to, and offset 50m west from, the eastern boundary of the ILUA Area at approximately Latitude 17.815556°South; thence southerly along that offset to the boundary of Roebuck Plains and Rubibi Community at Longitude 122.996020°East; thence generally easterly along the boundaries of Roebuck Plains and Rubibi Community back to the commencement point.
