Item 1 Description of Agreement Area

A. External boundary description

The agreement area includes all of the land and waters within Lot 5233 on PH1356 (Craiglee North Pastoral Holding) and Lot 5234 on PH1357 (Craiglee South Pastoral Holding) located within the Native Title Determination Application QUD85/05 Gugu Badhun People 2 (QC05/07) being an area excluding former Exploration Permit 13873 and south of a line described below:

Use of Coordinates

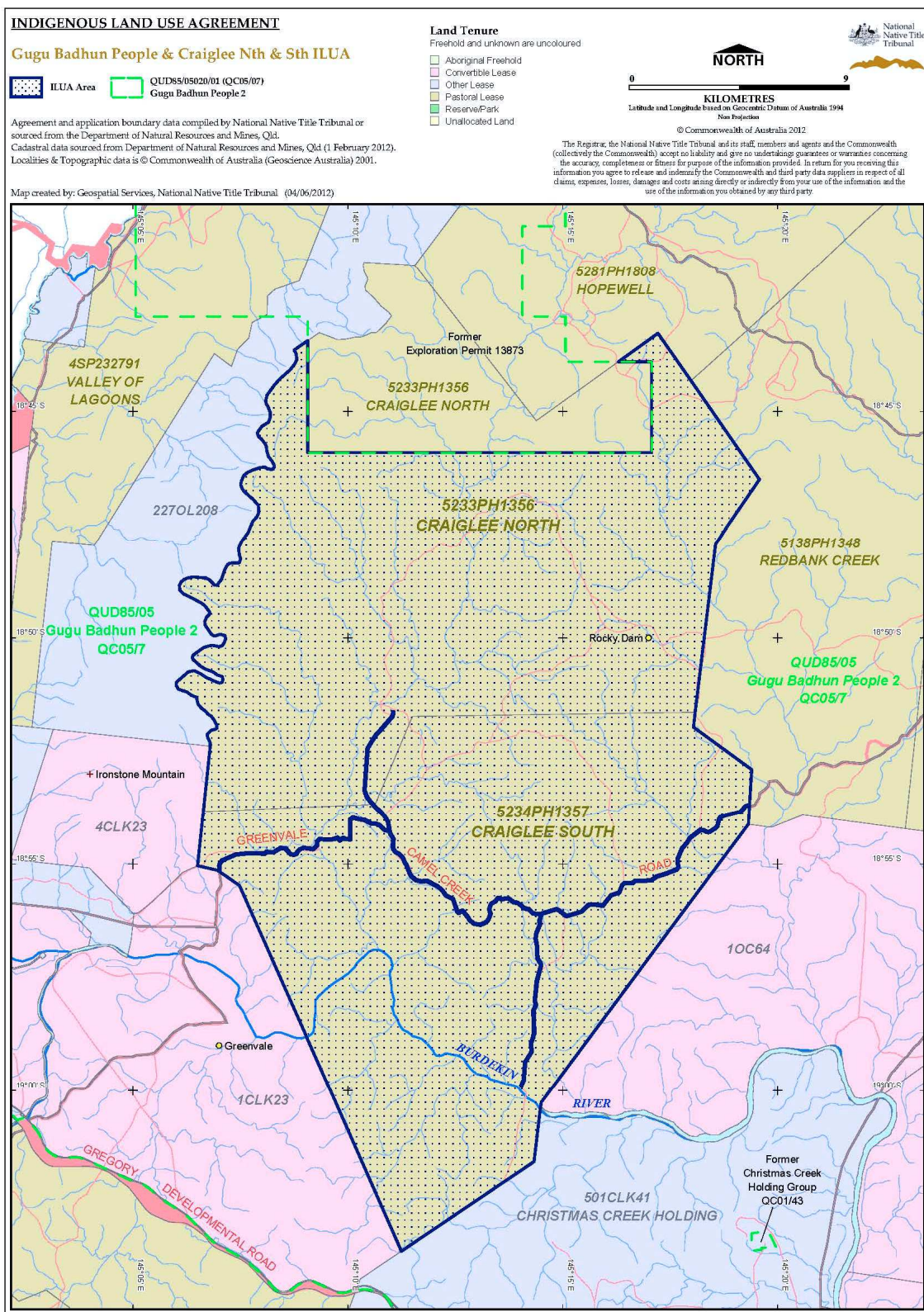
