- 2.1 Subject to clause 2.2, this Agreement commences on the Execution Date.
- 2.2 Clauses 8 and 11 commence on Registration.

Statements of the kind mentioned in ss. 24EB(1) or 24EBA(1) or (4)

- 8.1 The Parties consent to:
- (a) the Surrender; and
- (b) the Grant.
- 8.2 The Parties agree that the Surrender is intended to extinguish any Native Title in relation to the ILUA Area at the time of the Surrender.
- 8.6 For the purposes of section 24EB(1)(c) of the NTA and regulation 7(5)(b) of the Regulations, Subdivision P of Division 3 of Part 2 of the NTA is not intended to apply to the Surrender or the Grant.

Grant means the grant of an estate in fee simple by the State over the ILUA Area by the issue of a deed of grant to J & MM Lowth.

NTA means the Native Title Act 1993 (Cth).

Surrender means the intended extinguishment of Native Title over the ILUA Area.
