

**SCHEDULE 1**

**Description of ILUA Area**

The ILUA Area falls within the external boundary of native title determination application WAD78/05 Ngarlawangga people (WC05/3) and covers all the land and waters within the external boundary described as:

- (a) Commencing at a corner on the south western boundary of native title determination application WAD78/05 Ngarlawangga people (WC05/3), also being a point on the western boundary of Pastoral Lease 3114/1125 (Prairie Downs) at Latitude 23.506252° South and extending generally westerly and generally northerly along boundaries of that native title determination application passing through the following coordinate points:

- (b) Then north easterly along a line extending to Longitude 118.881488° East Latitude 23.059844° South, being again the western boundary of native title determination Application WAD78/05 Ngarlawangga people (WC05/3), to Longitude 118.879717° East; then south easterly to a corner on the eastern boundary of native title determination application WAD78/05 Ngarlawangga people (WC05/3) at Longitude 119.141883° East Latitude 23.249178° South; then south-easterly along a line extending to Longitude 119.294876° East, Latitude 23.477452° South, being again that native title determination application boundary to Longitude 119.233333° East, also being the intersection with the eastern boundary of mining tenement E52/2043-I; then generally southerly along eastern boundaries of that mining

tenement, eastern and southern boundaries of M52/870 and southern boundary of again mining tenement E52/2043-I to its southern most western corner; then westerly back to the commencement point.
