### Description of the area covered by the agreement

The agreement area covers all the land and waters subject to those parts of Lot 4266 on PH34 (Guthalungra Term Lease) and Lot 91 on SB749 (Nobbies Pastoral Holding) which fall within the native title determination application QUD544/2010 Juru People (QC2013/010).
