Description of Gudjala ILUA Area

External boundary description

1. The ILUA Area covers all the land and waters within the external boundary described as: Commencing at the northern most corner of Lot 551 on Plan CP843339 (Maryvale) and extending generally south easterly along the north eastern boundary of that lot to its intersection with the western bank of the Clarke River; then generally south westerly along the western bank of that river to its intersection with the eastern boundary of Lot 5014 on Plan PH260 (Wade Holding); then generally southerly, generally south westerly, generally westerly and generally northerly along the south eastern and western boundaries of that lot and Lot 1 on Plan SP272205 (Dosey) to the southern boundary of Lot 575 on Plan PH219 (Shield Creek Holding); then westerly and generally northerly along southern and western boundaries of that lot to the intersection with the eastern boundary of the Gilbert Drainage Basin at Latitude 19.372758° South; then generally north easterly along that drainage basin boundary to its intersection with western boundary of Native Title Determination QUD80/2005 Gudjala People (QCD2014/006) at Latitude 19.346041° South; then generally north easterly along that native title determination boundary to its intersection with that drainage basin boundary at Latitude 19.332375° South; then generally north easterly again along that drainage basin boundary to its intersection with western boundary of again that native title determination at Latitude 19.318436° South; then generally north easterly and generally easterly along the western and northern boundaries of that native title determination to the intersection with the south eastern boundary of Lot 1 on Plan CLK40 (Porphyry Creek Holding) at Latitude 19.274124° South; then generally south westerly along the south eastern boundary of that lot back to the commencement point.

2. The ILUA Area also include lots:

- (a) Lot 45 on BKN802454.
- (b) Lots 1649, 1650 and 1651 on AP9326.
- (c) Lots 1437, 1438, 1349, 1350 and 1351 on AP9326.
