## Description of the area covered by the agreement

Schedule B of the agreement describes the agreement area as all the land and waters subject to that part of Pastoral Lease N049681 (Christmas Creek), excluding Historic Road 1, that falls within Native Title Determination Application WAD6217/1998 Kurungal (WC1997/101).

- (b) to the extent that this Agreement has force as an Indigenous Land Use Agreement, upon its Registration as an Indigenous Land Use Agreement.
