The agreement area covers all the land and waters within Brick House Pastoral Lease (N050631) that is within the external boundary of the Baiyungu / Thalanyji Prescribed Body Corporate Area, further described as:

That part of Brick House Pastoral Lease (N050631) that is north of a line commencing at Longitude 113.844350° East, Latitude 24.640980° South, being a point on the centreline of Cardabia Creek; then easterly to Binthalya Homestead at Longitude 114.837070° East, Latitude 24.688590° South.

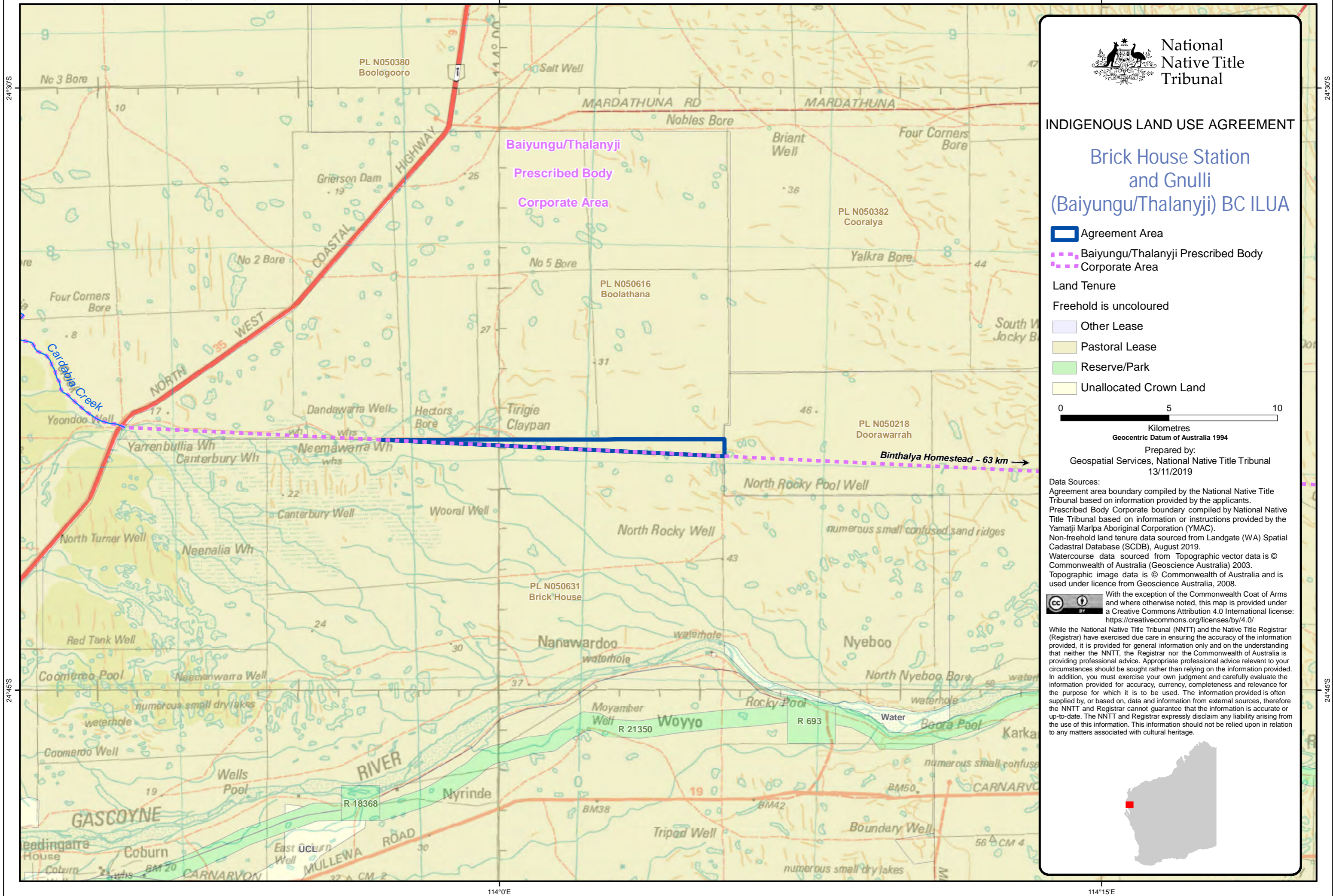
Reference datum

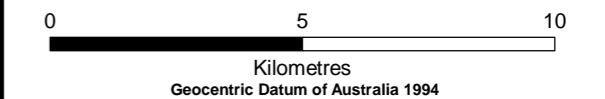
