# **External boundary description**

External boundary description

The agreement area covers all the land and waters within the external boundary described as that portion of the QUD19/2019 Gunggari People #4 (QC2012/014) native title determination application that lies within the boundaries of the Maranoa Regional Council Local Government Authority, further described as:

Commencing at the intersection of the western boundary of the Maranoa Regional Council Local Government Authority and a line joining Longitude 147.221212° East, Latitude 26.712705° South and Longitude 147.270501° East, Latitude 26.712777° South, being the southern boundary of the QUD19/2019 Gunggari People #4 native title determination application (QC2012/014); and extending generally northerly and north westerly along the western boundary of that Local Government Authority to the intersection with the western boundary of the Balonne-Condamine River Basin catchment area at approx. Latitude 25.809845° South; then north westerly along the boundary of that catchment area to again the intersection with again the Maranoa Regional Council Local Government Authority boundary at a point at Latitude 25.795771° South; then generally north easterly, northerly and westerly again along the western boundary of that Local Government Authority boundary to again a point on the western boundary of that catchment area at Latitude 25.791700° South; then north westerly and generally north easterly along the western boundary of that catchment to its intersection with the northern boundary of Lot 6 on BDR97 (Hillside) at Longitude 147.497631° East; then north easterly to the southernmost south-eastern corner of Lot 4234 on SP271523; then generally northerly along eastern boundaries of that lot, and generally north-easterly along south-eastern and eastern boundaries of Lot 6 on CHS25 to the northern boundary of Maranoa Regional Council Local Government Authority at approx. Latitude 25.033438° South; then generally north easterly along the northern boundary of that Local Government Authority to its intersection with the southern boundary of Native Title Determination QUD216/2008 Bidjara People (QCD2014/002); then generally south easterly along the southern boundary of that determination to its intersection with the north westernmost corner of Lot 5317 on WT805970 (Sardine Creek Holding) at approximate Longitude 148.352036° East; then generally south easterly, and generally southerly along western boundaries of Lot 5317 on WT805970 and Lot 88 on FTY1706 to again the boundary of the Balonne-Condamine River Sub Basin catchment at Latitude 25.445444° South; then generally southerly along the eastern boundary of that catchment area to a point at Latitude 26.070781° South; then generally south easterly to a point on the southern boundary of an unnamed road, being the northernmost corner of Lot 19 on WV731, at 26.097998° South, passing through the following points:
