External boundary description

The area subject to this agreement covers all land and waters subject to:

That part of Bulloo Downs Pastoral Lease (N049943) that falls within Native Title Determination Application WAD78/2005 Ngarlawangga People (WC2005/003) as accepted for registration on 30 October 2013; further described as:

That part of Bulloo Downs Pastoral Lease (N049943) that falls west of a line commencing at the intersection of Longitude 119.363043° East and a line joining Longitude 119.294876° East, Latitude 23.477452° South and Longitude 119.564249° East, Latitude 23.586534° South, being a point on the western boundary of native title determination application WAD6280/1998 Nyiyaparli (WC2005/006), and extending south easterly to the intersection of Latitude 23.800165° South and a line joining Longitude 119.730433° East, Latitude 23.799776° South and Longitude 119.721689° East, Latitude 24.050851° South, again a point on the western boundary of native title determination application WAD6280/1998 Nyiyaparli (WC2005/006); then generally southerly along boundaries of that native title determination application passing through the following coordinate points:

Nharnuwangga at Longitude 119.643774° East, also being a southern boundary of Bulloo Downs Pastoral Lease (N049943).
