Description of the area covered by the agreement

The Agreement Area includes the entirety of NT Portions 5162, 5163 and 4868 (as depicted on the Map at Schedule 1 of the Agreement) and an area of land proposed for surrender from Ammaroo Pastoral Lease and grant as Aboriginal land (as depicted on the map at Schedule 3.2 of the Agreement).

[A copy of Schedules 1 and 3.2 is attached to this register extract.

The following general description of the agreement area has been provided by the National Native Title Tribunal to assist people to understand the location of the agreement area. It is provided for information only and should not be considered part of the Register of ILUAs:

The agreement area covers about 193 sq km in the vicinity of Ammaroo Station (PPL 1,105), about 250 km north east of Alice Springs.]

2. Term

- (a) This Agreement commences on the first day all parties have executed the Agreement.
(b) The Agreement will continue in perpetuity and has such legal effect as is prescribed by the Native Title Act and the regulations upon being entered on the ILUA Register.

Statements of the kind mentioned in ss. 24EB(1) or 24EBA(1) or (4)

4.(a) The Native Title Party agrees to surrender to the Territory any exclusive native title rights which may be capable of recognition over the Former Stock Routes and Former Stock Reserve.

(b) The Parties agree to:

(i) the incorporation of the Former Stock Routes and Former Stock Reserve into Ammaroo pursuant to s 65 of the PLA; and

(ii) use of the Former Stock Routes and Former Stock Reserve by the Lessee for pastoral purposes pending incorporation of these areas into Ammaroo.

(c) The Lessee agrees, subject to receiving the Minister's consent under section 60 of the PLA, to surrender the Land described in Schedule 3.1 and as depicted on the map attached at Schedule 3.2 to this Agreement.

(the Agreed Actions).

5.(a) The Parties consent to the doing of the Agreed Actions, whether or not any of the Agreed Actions are Future Acts.

(b) The Native Title Party acknowledges that:

(i) incorporation of the Former Stock Routes into Ammaroo is “a previous offer, commitment, arrangement or undertaking made or given in good faith on or before 23 December 1996” within s 24IB(b) of the NTA; and

(ii) the incorporation of the Former Stock Routes could thereby validly be done as a PERBA.

6.(a) The surrender of exclusive native title set out in clause 4(a) of this Agreement is intended to extinguish any exclusive native title rights and interests that may be capable of recognition in the Former Stock Routes and Former Stock Reserve.

7.(a) Subdivision P (Right to Negotiate), Part 2 of Division 3 of the NTA is not intended to apply to any Future Act described in clause 5.
