Description of the area covered by the agreement

The area subject to this agreement is defined in Clause 1.1 as: 'ILUA Area means the area described in writing in Schedule 1 and shown on the map in Schedule 1'.

The following general description of the agreement area has been provided by the National Native Title Tribunal to assist people to understand the location of the agreement area. It is provided for information only and should not be considered part of the Register of ILUAs:

The Agreement Area covers about 305 sq km, located approx 14 km south west of Dalbeg and 116 km south of Townsville].

2.1 Subject to clause 2.2, this ILUA commences on the Execution Date.

2.2 Clause 3 commences on Registration.

2.3 This ILUA will terminate one month after the Approved Dealings have been completed.

Statements of the kind mentioned in ss. 24EB(1) or 24EBA(1) or (4)

3.1 The parties consent to the Approved Dealings, being:

(a) the incorporation of the land described as Lot 14 on Crown Plan MRY12, Title Reference 47012950, which is a camping and water reserve, into the rolling lease (designated TL 0/237928) Title Reference 40068856; and

(b) the issue by the State to the five members of the Spurdle family of a permit to occupy over for grazing purposes over the land described as Lot 1 on Crown Plan AP 2068, Title Reference 47018912.

3.2 The parties agree that the Approved Dealings are not intended to extinguish any Native Title in relation to the ILUA Area.

3.3 For the purposes of Section 24EB(1)(c) NTA, Subdivision P, Part 2, Division 3 of the NTA is not intended to apply to the Approved Dealings.

3.4 For the purposes of Section 24EBA(1)a(i) & (ii) NTA, this Agreement does not contain provisions that create an intermediate period act or of such acts included in classes, that have already been done invalidly; and

3.5 For the purposes of Section 24EBA(1)a(iii) NTA, there is no agreement by the parties to change the effect on native title of validation of an intermediate period act or of such acts included in classes.

Definitions

Approved Dealings means the PTO Reissue, and the Reserve Land Incorporation [being, respectively, the "Approved Dealings" cited in clause 3.1, above.]
