Description of the area covered by the agreement

6.1 This Agreement covers the Agreement Area.

6.2 If there is an inconsistency between the description of the Agreement Area in Schedule 1 and the map in Schedule 2, the description in Schedule 1 prevails.

"**Agreement Area**" means the land or waters as described in Schedule 1 and delineated by the map in Schedule 2.

The agreement area covers Lot 5107 on PH620, Lot 59 on SK3, Part Lot 4 on SP120452, Lot 1 on LA2 and Lot 2 on WON4, with a combined area of about 4,326 sq km, located approx. 50 km south of Normanton.]
