THE ILUA AREA

Mapoon Aboriginal Shire Council & Northern Cape York Group #2 ILUA

Boundary description

The agreement area covers all the land and waters within that part of native title determination application QUD156/2011 Northern Cape York Group #2 (QC2011/003) within the Mapoon Aboriginal Council Local Government boundary, further described as:

- Lot 6 on SP140905
- Commencing at the seaward extremity at High Water Mark of the northern bank of the Pennefather River and extending generally north easterly along the coastline of the Gulf of Carpentaria at the High Water Mark and across the mouths of any waterways flowing into the Gulf of Carpentaria between the seaward extremities at High Water Mark of each of the opposite banks of each such waterway to the mouth of Port Musgrave; then generally southerly and generally easterly along the coastline of Port Musgrave at the High Water Mark and across the mouths of any waterways flowing into that port between the port extremities at High Water Mark of each of the opposite banks of each such waterway to the mouth of the Wenlock River; then generally southerly along the western bank of that river to Lot 7024 on MP41159; then generally south westerly, southerly and westerly along the boundary of Lot 2 on SP252512 to the Pennefather River; then generally westerly along the northern bank of that river, across the mouth of Turtle Creek, back to the commencement point.
- Commencing at the intersection of a northern boundary of Lot 7024 on MP41159, the eastern bank of the Wenlock River and western boundary of Lot 1 on SP204113 and extending generally north easterly along the northern boundary of that Lot to its northernmost point; then easterly to a point on the western boundary of Lot 3 on SP204113 at Longitude 141.940975° East, Latitude 12.167213° South, being again a point on the eastern bank of the Wenlock River; then generally northerly, generally easterly and generally north easterly along the eastern bank of that river and the coastline of Port Musgrave at the High Water Mark, crossing the mouths of any waterways flowing into that port between the port extremities at High Water Mark of each of the opposite banks of each such waterway to the mouth of the Ducie River at Latitude 12.049136° South; then generally northerly and generally easterly along the eastern and southern banks of that river to the western boundary of Lot 7024 on

MP41159; then generally south westerly and north westerly along the boundaries of that lot back to the commencement point.
