3.2 Subject to clause 3.1, this Agreement commences on the Commencement Date.

3.3 (a) Subject to clause 3.4, this Agreement terminates upon the earlier of the:

- (i) expiration, cancellation or surrender of the Exploration Licence and the Mineral Lease; or
- (ii) termination of this Agreement in accordance with clause 24.

## Statements of the kind mentioned in ss. 24EB(1) or 24EBA(1) or (4)

4.1 (a) For the purpose of section 24EB of the Native Title Act the Parties consent, subject to the provisions of this Agreement, to the following after the Commencement Date:

- (i) the grant of a Future Mineral Lease or Extractive Mineral Lease; and
- (ii) the renewal, extension, re-grant or variation of the Exploration Licence and the Mineral Lease; and
- (iii) the Company and the Personnel carrying out the Mining Activities and Mining Operation on the ILUA Area.

4.3 The Parties acknowledge and agree that Subdivision P, Division 3, Part 2 of the Native Title Act is not intended to apply to the acts and activities referred to in clause 4.1.

## Definitions

Exploration Licence means the exploration licence held by the Company specified in Item 2 (being EL25429) (including any renewals or substitutions) within the ILUA Area [...].

Extractive Mineral Lease means any extractive mineral lease granted to or held by the Company (including any renewals or substitutions) over any part of the ILUA Area.

Future Mineral Lease means a mineral lease or other mineral title granted to the Company under the Mineral Titles Act over any part of the ILUA Area after the Execution Date.

Mineral Lease means the mineral lease or mineral leases granted to or held by the Company specified in Item 1 [being ML30182 and 30180] and any Future Mineral Lease or Extractive Mineral Lease (including any renewals or substitutions) over any part of the ILUA Area.

Mining Activities means all activities carried out in undertaking the Mining Operation including accessing the ILUA Area, seismic surveying, drilling, digging, geological, geophysical and other exploration activities, and the development, production, gathering, separating, pressure maintenance, dehydrating, heating, treating, processing, handling, transportation, fractionation, storage and distribution and marketing of Minerals produced or to be produced on the ILUA Area, including the design, capacity, construction, installation, operation, maintenance, repair and replacement of all Mine Facilities.

Mining Operation means all operations and activities, carried out by or on behalf of the Company, for the recovery, mining, extraction, production, exploration, refining, or transportation of Minerals or Extractive Minerals or production of concentrates from Minerals on the ILUA Area.
