Description of the area covered by the agreement

The Agreement Area means the geographical area to which this Agreement applies, being portion of Pastoral Lease Number 2387 recorded in Crown Lease Register Book Volume 1597 Folio 92* known as Clifton Hills, portion of Pastoral Lease Number 2385 recorded in Crown Lease Register Book Volume 1323 Folio 47 known as Goyder Lagoon and portion of Pastoral Lease Number 2386 recorded in Crown Lease Register Book Volume 1323 Folio 48 known as Kanowana (excluding all public roads) that is within the external boundary of native title determination application SAD6016/98 The Wangkangurru Yarluyandi Native Title Claim (SC97/3) as amended on 13 November 2009, being an area west of a line defined as:

Commencing at Longitude 139.800759 East, Latitude 26.315911 South and extending generally south westerly passing through the following coordinate points:

Longitude 139.569764 degrees East, Latitude 26.693364 degrees South and
Longitude 139.367244 degrees East, Latitude 26.953967 degrees South

the latter also being a north western corner of native title determination application SAD6017/98 Dieri Native Title Claim (SC97/4), then south westerly along the boundary of that application to a point at 138.719232 degrees East, 27.787831 degrees South.
