

## SCHEDULE 1 – EXTERNAL BOUNDARY OF THE DETERMINATION AREA

The Determination Area is located wholly within and comprises all land and waters bounded by the following line:

Commencing at a point at the intersection of Mean Low Water Mark with a line between Longitude 138.077914 East, Latitude 35.579998 South and Longitude 138.501370 East, Latitude 35.565221 South [being a point on the southern boundary of Kurna Peoples Native Title Claim].

Then easterly in a straight line to the said Longitude 138.501370, Latitude 35.565221 South [portion being along the southern boundary of Kurna Peoples Native Title Claim].

Then north-easterly in a straight line to the west corner of Section 266, Hundred of Freeling; north-easterly along the northern boundaries of Section 266 and Section 267, Hundred of Freeling to a northern corner of Section 267 at Longitude 139.127852 East.

Then northerly in a straight line to Longitude 139.127841 East, Latitude 35.048551 South; easterly in a straight line to the north-east corner of Allotment 20 in Filed Plan 3571 [being a point on the western boundary of Boundary Road].

Then generally southerly along the western boundary of Boundary Road to the south-east corner of Section 576, Hundred of Burdett; south-easterly in a straight line to the north-west corner of Section 38, Hundred of Ettrick [being a point on the south-western boundary of Karoonda Highway].

Then generally south-easterly along the south-western boundary of Karoonda Highway to its intersection with Longitude 139.556736 (north-west of Wy-Not Homestead); generally south-easterly in straight lines through the following coordinate points :-

to the south corner of Allotment 59 in Deposited Plan 44226; south-easterly in a straight line to a north-eastern corner of Allotment 501 in Deposited Plan 41784 at Latitude 35.296244 South [being a point on the western boundary of Old Dukes Highway].

Then generally southerly, generally south-westerly and generally south-easterly along the western boundary of Old Dukes Highway to an eastern corner of Allotment 50 in Deposited

Plan 80339 at Latitude 35.469691 South; southerly in a straight line to the north-eastern boundary of Allotment 91 in Deposited Plan 60233 and its intersection with Latitude 35.470394 South [being a point on the south-western boundary of Dukes Highway].

Then generally south-easterly along the south-western boundary of Dukes Highway to its intersection with Longitude 140.022289 East (north-east of the Town of Tintinara). Then south-easterly in a straight line toward the point defined as Longitude 140.117230 East, Latitude 36.021610 South until it intersects the centreline of the Woods Well Road road reserve (south-west of the Town of Tintinara) [being the northern-most point of Native Title Claim First Nations of the South East #2 external boundary].

Then generally south-westerly along the centreline of the Woods Well Road road reserve to its intersection with the centreline of the Lake Ellen Road road reserve; southerly along the centreline of the Lake Ellen Road road reserve to its intersection with the centreline of the Gumwell Road road reserve; westerly along the centreline of the Gumwell Road road reserve to its intersection with the production northerly of the eastern boundary of the northern portion of Section 1, Hundred of Colebatch. Then southerly along the said production to the north-eastern corner of Section 1, Hundred of Colebatch [being the north-eastern corner of Messent Conservation Park]. Then southerly and along the eastern boundaries of the northern portion of Section 1, Hundred of Colebatch; Section 65, Hundred of Colebatch; the southern portion of Section 1, Hundred of Colebatch and the northern portion of Section 1, Hundred of Messent; south-westerly along the south-eastern boundary of Section 10, Hundred of Messent; southerly along the eastern boundary of the southern portion of Section 1, Hundred of Messent; generally south-westerly along the southern boundary of the southern portion of Section 1, Hundred of Messent to its intersection with the centreline of a private road in Section 22, Hundred of Messent [being along the eastern and a portion of the southern boundaries of Messent Conservation Park]. Then generally southerly and westerly along the centreline of the said private road to its intersection with the centreline of the Salt Creek Road road reserve. Then generally south-westerly along the centreline of the Salt Creek Road road reserve to its intersection with the centreline of the Princes Highway road reserve; generally north-westerly along the centreline of the Princes Highway road reserve to its intersection with Latitude 36.092509 South. Then south-westerly to a point being the intersection of Latitude 36.099539 South with the centreline of the main channel of the body of water known as The Coorong; generally south-easterly along the said centreline of the main channel of the body of water known as The Coorong to its intersection with the northern boundary of Section 59, Hundred of Neville; easterly along the northern boundaries of Section 59 and Section 56, Hundred of Neville and Allotment 7 in Deposited Plan 31585 to the north-east corner of Allotment 7 in Deposited Plan 31585 [being along the

northern portion and portion of the western portion of Native Title Claim First Nations of the South East #2 external boundary].

Then generally north-westerly, generally westerly, generally northerly and generally north-easterly along Mean Low Water Mark, across the mouths of any waterways flowing into the Southern Ocean between the seaward extremities at Mean Low Water Mark of each of the opposite banks of each such waterway to the point of commencement.
