- 3.1 Clauses 1 (Definitions), 2 (Interpretation), 3 (Commencement and Expiry), 4 (Authority) and 13 (Registration of Agreement) commence on the Execution Date.
- 3.2 The remaining clauses of this Agreement commence on Registration.
- 3.3 Subject to clauses 3.4 to 3.6, this Agreement will continue in force in perpetuity.
- 3.4 This Agreement may be terminated by written agreement executed by:-
- (a) the parties, if prior to the Determination taking effect for the whole of the Agreement Area; or
- (b) the PBC once it is the RNTBC for any part of the Agreement Area, and all parties other than the Native Title Party and the Other Claimant Party.
- 3.5 A party may only notify the Registrar in writing pursuant to section 199C(1)(c)(i) of the NTA that this Agreement has expired if:
- (a) each party has agreed in writing that the Agreement has so expired; or
- (b) if the parties are unable to agree that the Agreement has expired in whole or in part, any Dispute about that disagreement has been resolved in accordance with clause 15; or
- (c) the Federal Court has ordered that the details of the Agreement be removed from the Register of Indigenous Land Use Agreements.
- 3.6 If this Agreement is terminated or expires after the Agreement is Registered, or if this Agreement is removed from the Register of Indigenous Land Use Agreements, it does not affect any rights or obligations that may have accrued before expiration or termination or the validity of any Agreed Acts that took effect while this Agreement was Registered.

Statements of the kind mentioned in ss. 24EB(1) or 24EBA(1) or (4)

- 5.1 The parties:
- (a) consent to the doing of the Agreed Acts to the extent that they are Future Acts; and
- (b) agree to the validating of any of the Agreed Acts, which are also Future Acts, done prior to Registration.
- "Agreed Acts" means all acts necessary to give effect to this Agreement including but not limited to any acts done as part of, or in relation to, the acts specified in Schedule 3;
