

WRITTEN DESCRIPTION - EWAMIAN SMALL SCALE MINING ILUA

The agreement area only covers those land and waters which are subject to native title determination applications:

- QUD6009/99 Ewamian People #2 (QC1999/013) as accepted for registration on 9 July 2002, excluding Lot 7 on Plan LG6; and
- QUD6018/01 Ewamian People #3 (QC2001/016) as accepted for registration on 27 June 2002.

Further described as being that area within the external boundary described below:

External Boundary Description

Commencing at the junction of the centrelines of Gilbert and Einasleigh Rivers and extending generally easterly along the centreline of the Einasleigh River, also being the northern boundary of Etheridge Shire Council to a point where it meets the centreline of the Etheridge River at Longitude 142.971640° East; then generally northerly and generally easterly along the northern boundary of Etheridge Shire Council to the western boundary of Bulleringa National Park (being Lot 4620 on Plan PH1283); then southerly and easterly along boundaries of that National Park to its intersection with again the Etheridge Shire Council boundary, then generally easterly, southerly and generally south easterly along the boundaries of that shire council to the centreline of the Gulf Development Road; then easterly along the centreline of that road to the eastern boundary of the Undara Volcanic National Park (Lot 26 on Plan NPW874); then generally southerly along the eastern boundary of that National Park to a corner at Latitude 18.318607° South; then generally southerly through the following coordinate points:

Then southerly to the centreline of the Kennedy Development Road at Longitude 144.627718° East; then generally south westerly and generally southerly along the centreline of that road to the northern boundary of the Parish of Lyndhurst (approximately 12 kilometres south of the northern boundary of Lyndhurst Pastoral Lease (Lot 14 on Plan LH8) at Latitude 19.157756° South; then easterly, southerly, westerly, generally northerly and westerly along the boundaries of that parish to the south eastern corner of the Parish of Eastdale, further described by the following coordinate points:

Westerly to a point on the centreline of Einasleigh River at	19.297927
Then generally northerly along the centreline of Einasleigh River to	19.277905

Then southerly to Longitude 144.276932° East, Latitude 19.418126° South, then westerly along a line extending to the easternmost corner of Lot 5 on SP196211 (also being the intersection of the boundaries of the Parishes of Titterstone, Juntala and Blackcap) to the eastern boundary of Blackbraes Resource Reserve (Lot 1004 on Plan NPW962) at Latitude 19.410207° South; then southerly along the boundary of that reserve to Latitude 19.429141° South; then westerly along a line extending to Longitude 144.138569° East, Latitude 19.428360° South to the eastern boundary of an unnamed road at Latitude 19.428646° South; then generally northerly along the eastern boundary of that unnamed road to intersect again the line drawn to the easternmost corner of Lot 5 on SP196211 at Latitude 19.408391° South; then westerly along that line to the western boundary of that unnamed road at Latitude 19.408344° South; then generally southerly along the western boundary of that unnamed road intersect a line drawn between a point on the eastern boundary of Blackbraes Resource Reserve (Lot 1004 on Plan NPW962) at Latitude 19.429141 and Longitude 144.138569° East, Latitude 19.428360° South at Latitude 19.428628° South; then generally north westerly to a point on the western boundary of Blackbraes Resource Reserve (Lot 1004 on Plan NPW962) at Latitude 19.407603° South, passing through the following coordinate points:

Then generally northerly along the western boundary of Blackbraes Resource Reserve (Lot 1004 on Plan NPW962) to intersect again the line drawn to the easternmost corner of Lot 5 on SP196211 at Latitude 19.403761° South; then westerly to the easternmost corner of Lot 5 on SP196211 (also being the intersection of the boundaries of the Parishes of Titterstone, Juntala and Blackcap); then westerly and generally northerly along the northern and eastern boundaries of that lot, also being the southern boundaries of the Parish of Blackcap, to Latitude 19.384177° South; then westerly along the prolongation westerly of that southern boundary to the centreline of the Gilbert River (approximately 2 kilometres northeast and upstream of the intersection of Anning Creek with the Gilbert River) at Latitude 19.365354° South; then generally south westerly and generally north westerly along the centreline of that river back to the commencement point.

The agreement also includes the area covered by:

- Lot 2 on Plan VR7
- Lot 10 on Plan CD18

- Former Mining Lease ML30189

Exclusions

- The agreement area excludes the Bulleringa National Park (being Lot 4620 on Plan PH1283) located on the northern boundary of this agreement.
- Lot 7 on Plan LG6.

Reference datum
