4. COMMENCEMENT

4.1 The Parties agree that subject to clause 4.2, the Agreement commences upon the Execution Date and binds each of the Parties, their successors and permitted assigns.

6. TERMINATION

- 6.1 Subject to this clause 6, this Agreement will terminate when the first of the following has occurred:
- (a) the Parties agree in writing to terminate this Agreement; or
- (b) after the granting of Project Interests, the last interest in any of the Project Interests has been determined, surrendered, lapsed or otherwise terminated and Grafton Ngerrie LALC has, by written notice, notified the other Parties to that effect.

7. CONSENT TO THE PROJECTS, PROJECT INTERESTS and PROJECT ACTIVITIES

- 7.1 For the purpose of section 24EB of the NTA the Native Title Parties consent to the Project Interests, and the undertaking of the Projects and the Project Activities, to the extent they are Future Acts.
- 7.2 The Native Title Parties consent to:
- a) the Project Interests to the extent they affect the Land; and
- b) the undertaking of the Project Activities and the Projects on the Land.
- 7.11 For the purposes of section 24EB(1)(c) of the NTA and regulation 7(5) of the ILUA Regulations, the Parties state that, if this ILUA is Registered, Subdivision P of Division 3 of Part 2 of the NTA is not intended to apply to the grant or undertaking of the Project Interests or the undertaking of the Projects or the Project Activities as listed at Schedule 3.
