### Description of the area covered by the agreement

Clause 1.1 'Land' means all land and waters within the boundary of the Town of Batchelor in the Northern Territory of Australia as depicted at Annexure A of the Agreement and defined by the proclamation published in the Commonwealth of Australia Gazette No. G37, 20 September 1977.

[A map of the agreement area is contained in Annexure A of the agreement. A copy of Annexure A is attached to this register extract.]

The following general description of the agreement area has been provided by the National Native Title Tribunal to assist people to understand the location of the agreement area. It is provided for information only and should not be considered part of the Register of ILUAs:

The agreement area is about 10 sq km and comprises all land and waters within the Town of Batchelor.]

**2 Term**

(a) This Agreement commences on the date the last Party executes this Agreement and will continue in perpetuity.

**3 Future Acts**

**3.1 Surrender and Extinguishment**

(a) The Parties consent to the surrender of any native title rights and interests in the Land held by the Warai and Kungarakany Groups, whether or not this surrender is a Future Act.

(b) The Parties agree that the surrender of native title under this Agreement is intended to extinguish all native title rights and interests in the Land held by the Warai and Kungarakany Groups.

**3.2 Validation of Prior Acts**

(a) The Parties agree to the validation of all Prior Acts (if any) done invalidly by the Territory.

**3.3 Right to Negotiate**

(a) Subdivision P (Right to Negotiate), Part 2 of Division 3 of the NTA is not intended to apply to any Future Act described in this clause 3.
