- ii) extending east along that latitude to the point at the intersection of that latitude and the high water mark at Cape Missiessy;
- iii) thence generally southerly, generally south-easterly and generally south-westerly along that water mark to the point at the intersection of that water mark and the westernmost southern boundary of the Karajarri Determination Area, that point being located on the geodesic joining the point at latitude 19.197809° south longitude 121.625577° east and the point at latitude 19.196344° south longitude 121.442371° east;
- iv) thence westerly along that boundary to the westernmost point of that geodesic;
