SCHEDULE 1

DESCRIPTION OF THE LAND

The **Determination Area** comprises Lot 121 within the Town of Kalkarindji, excluding administrative Lots 126(A), 127(A), and 129(A) as depicted on Map 1.

The **ILUA Area** is all the land and waters within the boundary of the Town of Kalkarindji as proclaimed in the *Australian Government Gazette* on 5 October 1976, and as depicted on Survey Plan S83/205 and on Map 2.

Part A of the ILUA Area is the land and waters within the ILUA Area as depicted on Map 3 where native title rights and interests have been extinguished or are surrendered as follows:

- (b) parts of Lot 121 affected by the construction or establishment of public works, including roads and water level gauges. The roads are Janama Street, Japalyi Street, Whitlam Street, Libanangu Street, and Kalkarindji internal road as surveyed, and Dagaragu Access road to a width of 50 metres each side of the centreline save where a road reserve of that width would extend into any surveyed Lot other than Lot 121, whereupon it will only extend to abut the boundary of any surveyed Lot other than Lot 121;
- (c) the Buntine Highway within the boundaries of Lot 121 to a width of 50 metres each side of the centreline save where a road reserve of that width would extend into any surveyed Lot other than Lot 121, whereupon it will only extend to abut the boundary of any surveyed Lot other than Lot 121;
- (d) the caravan park extension being all that parcel of land in the Town of Kalkarindji in the Northern Territory of Australia containing an area 2440 square metres more or less, being that part of Lot 121 generally described as commencing at the northern corner of Lot 76, thence bounded by lines 37 degrees 10.4 metres; thence 137 degrees 2 minutes 117 metres; thence 239 degrees 42 minutes 37 metres; thence 333 degrees 23 metres; thence 239 degrees 42 minutes 9.145 metres; thence 16 degrees 21 minutes 13.3 metres along truncation of Lot 76; thence 333 degrees 69.265 metres along eastern boundary of Lot 76; thence 305 degrees 5 minutes 9.78 metres along north eastern boundary of Lot 76 to the point of commencement (as depicted on Map 4, and subject to survey);

- (e) the electricity supply fuel tank extension to Lot 91 being all that parcel of land in the Town of Kalkarindji in the Northern Territory of Australia containing an area 1770 square metres more or less, being that part of Lot 121 designated as Lot 132(A) and generally described as commencing at the southern corner of Lot 91, thence bounded by lines 229 degrees 55 minutes 50 seconds 30 metres; thence 319 degrees 55 minutes 50 seconds 84.04 metres to intersect southern boundary of Lot 130; thence 90 degrees 16.09 metres along southern boundary of Lot 130; thence 125 degrees 3 minutes 30 seconds 41.63 metres along boundary of Lot 130; thence 49 degrees 55 minutes 50 seconds 7 metres along boundary of Lot 130 to intersect south western boundary of Lot 91; thence 139 degrees 55 minutes 50 seconds 33.445 metres along south western boundary of Lot 91 to the point of commencement (as depicted on Map 4, and subject to survey);
- (f) the school housing land extension being all that parcel of land in the Town of Kalkarindji in the Northern Territory of Australia containing an area 4530 square metres more or less, being that part of Lot 121 designated as Lot 133(A) and generally described as commencing at the northern corner of Lot 73, thence bounded by lines 212 degrees 30 minutes 55.29 metres along western boundary of Lot 73 and north western boundary of Whitlam Street; ; thence 302 degrees 30 minutes 82 metres; thence 32 degrees 30 minutes 55.29 metres; thence 122 degrees 30 minutes 82 metres to the point of commencement (as depicted on Map 4, and subject to survey);
- (g) the western housing land extension being all that parcel of land in the Town of Kalkarindji in the Northern Territory of Australia containing an area 2.96 hectares more or less, being that part of Lot 121 designated as Lot 134(A) and generally described as commencing at the south western corner of Lot 106, thence bounded by lines 269 degrees 59 minutes 62 metres; thence 359 degrees 59 minutes 468.945 metres; thence 89 degrees 59 minutes 104 metres to north western corner of Janama Street; thence 179 degrees 59 minutes 15.745 metres along western boundary of Janama Street to north eastern corner of Lot 120; thence 272 degrees 31 minutes 10 seconds 42.53 metres along northern boundary of Lot 120; thence 179 degrees 49 minutes 50 seconds 192.055 metres along western boundaries of Lots 120, 119, 118, 117,116,115 and extending to the north western corner of Lot 109; thence 179 degrees 59 minutes 263.02 metres along western boundaries of Lots 109, 108, Public Road, Lots 107, 102, 103, 104, 105 and 106 to the point of commencement (as depicted on Map 4, and subject to survey);
- (h) the health centre extension to Lot 125 being that parcel of land in the Town of Kalkarindji in the Northern Territory of Australia containing an area 6690 square metres more or less, being that part of Lot 121 designated as Lot 135(A) and generally described as commencing at the north western corner of Lot 125; thence bounded by lines 179 degrees 59 minutes 90 metres along the western boundary of Lot 125; thence 89 degrees 59 minutes 50 metres along the southern boundary of Lot 125; thence 179 degrees 59 minutes 30 metres along the western boundary of Libanangu Road to the north eastern corner of Lot 111; thence 269 degrees 59 minutes 93.275 metres along the northern boundaries of Lot 111 and 110 and Janama Street; thence 359 degrees 59 minutes 120 metres; thence 89 degrees 59 minutes 43.275 metres to the point of commencement (as depicted on Map 4, and subject to survey);

(i) all that parcel of land in the Town of Kalkarindji in the Northern Territory of Australia containing an area of 1.18 hectares more or less being that part of Lot 121 commencing at the south east corner of Lot 97 thence along the eastern boundary of Lot 97 to the boundary of Lot 90, thence along the southern boundary of Lot 90 to the boundary with Lot 98, thence along the western boundary of Lot 98 and Lot 99 to the south west corner of Lot 99, thence 279 degrees 28 minutes 94.06 metres to the point of commencement (subject to survey)

Part B of the ILUA Area is all the land and waters within the ILUA Area excluding Part A of the ILUA Area, as depicted on Map 3.
