The native title claim group on whose behalf the claim is made is the Yulluna People. The group comprises Aboriginal people who are:

(a) the biological descendants of

- * Mick Moonlight;
- * Willie Sullivan;
- * Rosie O'Sullivan;
- * Kitty Casey;
- * Momas;

(b) identify themselves as members of the Yulluna People; and

(c) are recognised by others who are Yulluna People as being Yulluna People

Native title rights and interests claimed:

1. Over areas where a claim to exclusive possession can be recognised, the Yulluna People claim the right to possess, occupy, use and enjoy the lands and waters of the application area to the exclusion of all others, pursuant to the traditional laws and customs of the claim group.

2 Over areas where a claim to exclusive possession cannot be recognised, the following rights and interests are claim:

(a) the right to access the area;

(b) The right to camp, and for that purpose build temporary shelters on the area;

(c) The right to hunt, fish and gather on the land and waters of the area for the personal, domestic and noncommercial communal purposes;

(d) The right to take and use Natural Resources from the land and waters of the area for personal, domestic and non-commercial communal purposes;

(e) The right to take and use the Water of the area for personal, domestic and non-commercial communal purposes; (f) The right to conduct ceremonies on the area;

(g) The right to maintain places of importance and areas on significance to the native title holders under their traditional laws and customs and protect those places and areas from physical harm;

(h) The right to teach on the area the physical and spiritual attributes of the area; and

(i) The right to light fires on the area for domestic purposes including cooking, but not for the purpose of hunting or clearing vegetation.

Area covered by the claim (as detailed in the application):

Subject to paragraphs 1 to 4 below, the area covered by the application is all of the land or waters within Lot 103 on USL703 located near the town of Duchess in the State of Queensland.

1. The area covered by the application excludes any land or waters within the claim area covered by valid previous exclusive possession acts as defined by section 23B of the Native Title Act 1993 (Cth).

2. Exclusive possession is not claimed over areas which are subject to valid previous non-exclusive possession acts done by the Commonwealth or the State of Queensland.

3. The area covered by the application excludes any land or waters where the native title rights and interests claimed have been otherwise extinguished.

4. If any of the land or waters referred to in 1, 2 or 3 above are subject to extinguishment that is required to be disregarded under subsection 47B(2) of the Native Title Act (Cth), then the area is not excluded from the application.
