## Description of the area covered by the agreement

**Agreement Area** means that part of the Lease Area which is contained within the external boundaries of the Claim Area in the Native Title Claim, and which is described in Schedule 1 to this Agreement.

The following general description of the Agreement Area has been provided by the National Native Title Tribunal to assist people to understand the location of the Agreement Area. It is provided for information only and should not be considered part of the Register of ILUAs:

The Agreement Area covers about 599 sq km and is located approx 138 km south west of Springsure, 89 km north west of Injune and 102 km north east of Augathella.]

5.1 Subject to clauses 5.2, 5.3 and 5.4, this Agreement takes effect on the date that the last party signs this Agreement, and continues until:

- (a) the date of expiry of the Lease term; or
- (b) the date of surrender, resumption, forfeiture or termination of the Lease; or
- (c) the date of removal of the Agreement from the Register of Indigenous Land Use Agreements.

5.2 Part A of this Agreement commences on the date that a determination of native title in favour of the Gunggari People takes effect in respect of the Native Title Claim area including the Agreement Area.

5.3 Part B of this Agreement commences in accordance with clause 6.5.

6.5 In the event that the Lessee elects to have this Agreement approved as an Indigenous Cultural Interest and registered:

- (a) the terms in Part B commence; and
- (b) the Lessee will give written notice of that election to the Gunggari Party.

**Land Act** means the *Land Act 1994* (Qld).

**Lease** means the leases under the Land Act held by the Lessee set out in Item 2 of Schedule 1, and includes, where the context permits, any renewal or extension of those leases or any new leases that replaces those leases.

**Lessee** means the holder of the Lease, described in Item 3 of Schedule 1, and also includes, where the context permits it, all of the Lessee's employees, contractors, agents, invitees and all family members or others who cohabit with the Lessee.
