## Description of the area covered by the agreement

1.1 'Agreement Area' means the Land and Waters described in Schedule 3 and shown on the map in Schedule 4, over which the Gangalidda and Garawa People will gain access to and exercise their respective Native Title Rights and Interests.

[A description of the agreement area is contained in Schedule 3 of the agreement. A map of the agreement area is contained in Schedule 4 of the agreement. A copy of Schedules 3 and 4 is attached to this register extract.

The following general description of the agreement area has been provided by the National Native Title Tribunal to assist people to understand the location of the agreement area. It is provided for information only and should not be considered part of the Register of ILUAs:

The agreement area covers about 2605 sq km adjacent to the Northern Territory/Queensland boarder approximately 137km north west of Burketown.]

3.1 This agreement commences on the Commencement date.

8.1 Subject to clause 8.4, this Agreement takes effect on the Commencement Date, and continues until:

Brisbane QLD 4001

(a) the date of expiry of the Lease term; or

(b) the date of surrender, resumption, forfeiture or termination of the Lease; or

(c) the date of removal of the Agreement from the Register of Indigenous Land Use Agreements.

8.4 Unless otherwise agreed, this Agreement will end with the valid extinguishment of Native Title over the whole of the Agreement Area.

'Commencement Date' means the day on which this agreement is executed by the Parties and, if executed on different days, the later of those days.
