Item 1 Description of Agreement Area

A. External boundary description

The agreement area includes all of the land and waters within Lot 4594 on PH1586 (Conjuboy Pastoral Holding) located within the Native Title Determination Application QUD85/05 Gugu Badhun People 2 (QC05/07) being an area east of the line described below:

Commencing at a point on the centreline of the Kennedy Development Road at The Lynd Junction and extending generally north westerly along that centreline to Latitude 18.735405° South; then generally northerly through the high points on the Great Dividing Range defined by Longitude 144.639483° East, Latitude 18.652717° South and Longitude 144.644847° East, Latitude 18.535674° South.

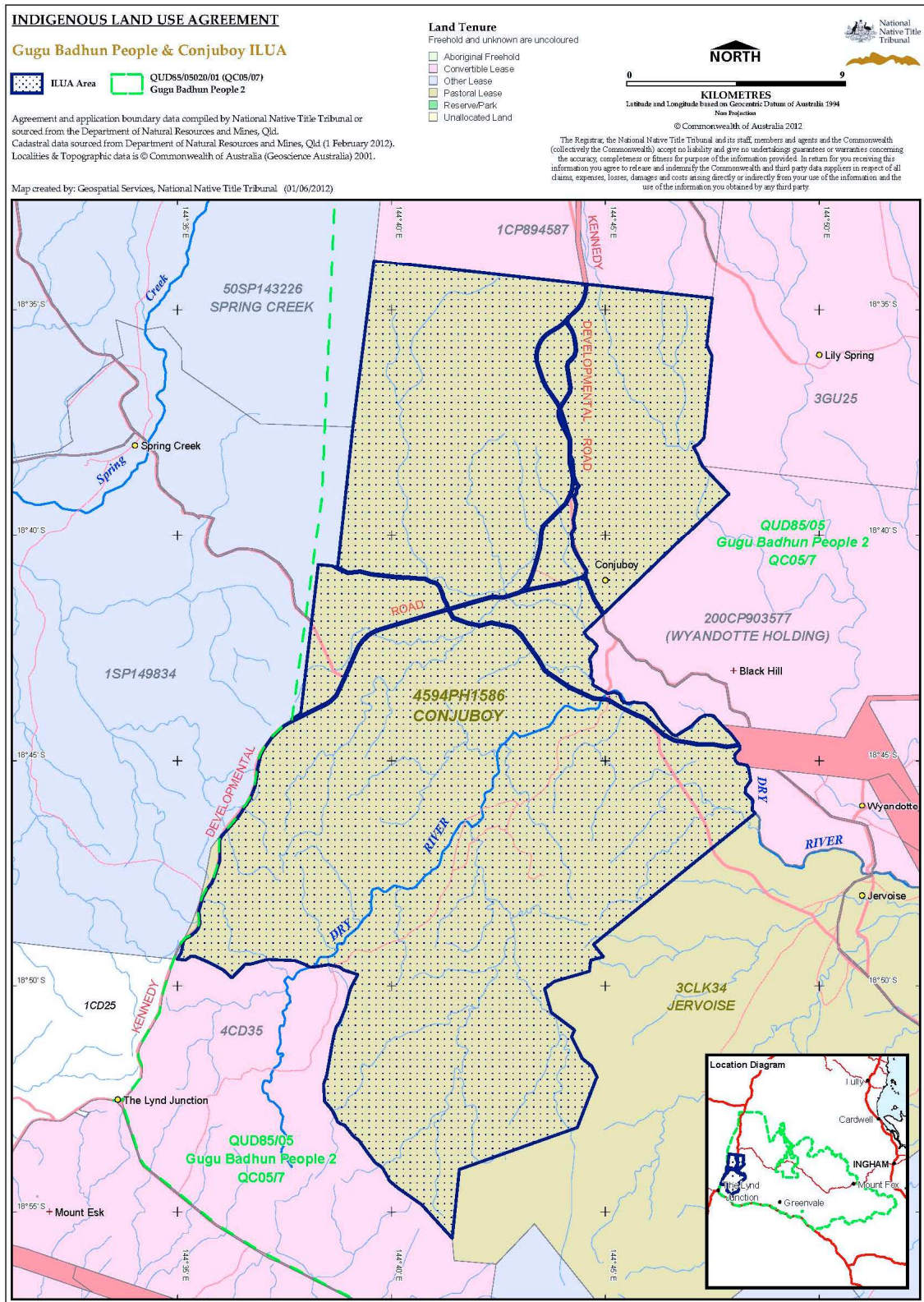
Reference Datum
