- 3.1 Subject to clause 3.2, this ILUA commences on the Commencement Date [being 5 August 2015] and will operate for the life of the Charleston Dam.
- 3.2 Clause 8 commences on Registration.

Statements of the kind mentioned in ss. 24EB(1) or 24EBA(1) or (4)

- 4.4 Subdivision P of Division 3 of Part 2 of the NTA [Native Title Act 1993 (Cth)] is not intended to apply to any Future Acts for which the Parties have given consent under this ILUA.
- 7.1 The Parties consent to Council accessing the ILUA Area and the undertaking of works within the ILUA Area associated with the design and construction of the Charleston Dam including geotechnical investigations, survey and earth works associated with establishment, construction and operation of the Charleston Dam and access thereto, after the Commencement Date and prior to Registration.
- 8.1 The Parties consent to:
- (a) the Agreed Acts; and
- (b) the Future Acts described in clause 7 (to the extent they are Future Acts); and
- (c) the validation of any of those Future Acts described in clause 7, pursuant to section 24EBA(1) of the NTA, that take place after the Commencement Date and prior to Registration.

"Agreed Acts" means:-

- (a) the dedication of the Charleston Dam Recreation Reserve by the State;
- (b) the appointment of Council as trustee of the Charleston Dam Recreation Reserve;
- (c) the use and development of the Charleston Dam and the Charleston Dam Recreation Reserve for recreational purposes including as a recreational dam and water supply for Forsayth and Georgetown within the ILUA area;
- (d) the grant of any applicable authorisations required for the development of the Charleston Dam within the ILUA Area: and
- (e) the undertaking of all works, operations and infrastructure that are to be undertaken in relation to or incidental to the investigation, implementation, development, construction, installation, operation, maintenance, repair, replacement, further development and any decommissioning in relation to the Charleston Dam in the ILUA Area;
