6.1(a) *[Barada Barna Aboriginal Corporation RNTBC]* and the Barada Barna People consent to the doing of the following acts, whether or not they are Future Acts:

- (i) the grant of the Tenements within the ILUA Area;
- (ii) the grant of any Approvals within the ILUA Area; and
- (iii) the undertaking the Project within the ILUA Area.

6.3(d) For the purposes of s 24EB(1)(c) of the NTA *[Native Title Act 1993 (Cth)]*, Subdivision P, Division 3 of Part 2 of the NTA is not intended apply to the grant of the Tenements or Approvals.

**Approvals** means any authorisation, lease, title, tenure, licence, permit, approval, certificate, declaration, regulation, consent, direction or notice whether or not from any government, judicial or other competent authority that Vitrinite or its Related Parties, acting reasonably, considers is necessary or desirable for, or incidental to, the undertaking of the Project.

**Mining Interests** has the meaning given under the *Mineral Resources Act 1989* (Qld).

**Project** means the planning, design, development, construction, extension, operation, maintenance, decommissioning, and rehabilitation of:

- (a) a mine or mines; and
- (b) any other works, infrastructure or operations Vitrinite considers in its unfettered discretion, reasonably necessary for or ancillary to the mine or mines, connected or related to the Tenements or Approvals.

**Related Parties** means:

- (a) Vitrinite's Related Bodies Corporate; and
- (b) any partnership, joint venture, or incorporated or unincorporated body which is Controlled by, or Controls, Vitrinite or any of its Related Bodies Corporate, and, for the avoidance of doubt, as at the Execution Date includes:
- (c) Queensland Coking Coal Pty Ltd ACN 129 600 004; and
- (d) Qld Coal Aust No.1 Pty Ltd ACN 135 731 154.

**Tenements** means any Mining Interests applied for by or granted to Vitrinite, or a Related Party, including any renewal, conversion, replacement, substitution, consolidation, variation, addition of surface area, addition of excluded land or restricted land, or extension of those interests.
