Description of the area covered by the agreement

"ILUA Area" is defined as the land and waters described in Schedule 1 and shown on the map in Schedule 2.

Schedule 1 of the agreement describes the agreement area as all of the land and waters described as Lot 3 on Plan AY23 (Wilandspey Conservation Park) and Lot 7 on Plan NPW199 (Blackwood National Park).

[A map of the agreement area is contained in Schedule 2 of the agreement. A copy of Schedules 1 and 2 are attached to this register extract.

The following general description of the agreement area has been provided by the National Native Title Tribunal to assist people to understand the location of the agreement area. It is provided for information only and should not be considered part of the Register of ILUAs:

Agreement covers about 72 sq km in two portions: about 16 sq km over the Blackwood National Park; and about 56 sq km over the Wilandspey Conservation Park.]
