

**Technical Description – Proposed ILUA Area (within Nyikina Mangala Determination Area)**

**Description of External Boundary**

**Area 1**

Commencing on a western boundary of Native Title Determination Nyikina Mangala WAD6099/1998 (NTD Nyikina Mangala), being a western boundary of Yakka Munga Pastoral Lease 3114/1194, at the easternmost southeastern corner of Native Title Determination Rubibi Community WAD6006/1998, WAD223/2004 (NTD Rubibi Community); thence extending generally northerly along the boundaries of that pastoral lease and those determinations to Latitude 17.989869°South; thence extending generally easterly through the following coordinates:

Thence generally northerly, generally easterly, generally southerly, generally westerly and generally northerly through the following coordinates:

Thence generally westerly through the following coordinates:

Thence generally westerly back to the commencement point.

**Area 2**

Commencing at a southwestern corner of NTD Nyikina Mangala, being an eastern boundary of Roebuck Pastoral Lease 3114/499 and coincidental with a boundary of NTD Rubibi Community at approx. Latitude 17.815081°South and Longitude 122.996091°East; thence extending generally northerly along the boundaries of that lease and those determinations to a northeastern corner of NTD Rubibi Community at approx. Latitude 17.732290°South and Longitude 122.996086°East; and continuing generally northerly along boundaries of NTD Nyikina Mangala to Latitude 17.723254°South; thence generally north easterly, generally south easterly and generally south westerly through the following coordinates:

Thence generally southerly to a boundary of NTD Nyikina Mangala (being a point on the boundaries of Roebuck Pastoral Lease 3114/499 and NTD Rubibi Community) at Longitude 122.996563°East; thence generally westerly along the boundaries of that lease and those determinations back to the commencement point.

### **Exclusions**

The following areas are excluded from the above application:

- Native title determination application WAD6006/1998, WAD223/2004 Rubibi Community (WCD2006/001) as registered on the National Native Title Register on 23/05/2006.
- Native title application WAD295/2012 Karajarri Yanja (WC2012/011) as entered on the Register of Native Title Claims on 22/11/2012.

#### **Reference Datum**
